If the installer is unavailable, then the customer can contact ASWF.

COVERAGE

This warranty covers the replacement of defective product and excludes labor charge of re-installation. All warranty claims are subject to review by American Standard Window Film.

LIMITATIONS

Warranty coverage is only provided for products installed by ASWF certified installers and that were properly stored, maintained and installed. This limited warranty does not apply to any product damages or damages to the vehicle/paint that may be caused by accident, physical impact, harsh chemicals, fallout, acts of God, normal wear and tear, degradation, or improper maintenance such as power washing, buffing, polishing or detailing. Fresh paint must cure a minimum of 90 days before installing the film, however the warranty is void. The warranty is void if film was installed incorrectly by an unauthorized or authorized installer; or if the purchaser fails to maintain the product properly after installation.

The obligation of ASWF under this warranty is limited to replacement of products not conforming to the warranty. The product is to be used in compliance with all applicable state and provincial laws. PROPER CARE & MAINTENANCE

To ensure the product remains in excellent condition, please follow the proper care & maintenance instructions. Failure to adhere to these instructions can void product warranty.

- Do not wash or wax your vehicle for a minimum of 7 days after installation.
- Wash and wax your vehicle as needed.
- Remove any and all bugs, tar, oil, dirt, chemicals, etc from film as soon as possible to prevent staining.
- Do not use solvent based bug and tar remover or cleaners.
- Use soft non-abrasive wash mitts and drying materials.
- If powerwashing, wait at least 30 days after installation and keep the spray tip at least 3 feet away from film.
- Non-abrasive wax or sealant application is recommenced once every 4 months.
- The use of polishing compounds, clay bars or waxes that contain dyes or abrasives is prohibited.
- Seek ASWF certified installer to remove film if needed.
